

CONSTITUTION OF
COED SOCCER ASSOCIATION OF HAWAII

ARTICLE ONE

NAME

The name of the nonprofit organization shall be the Coed Soccer Association of Hawaii hereinafter referred to as the 'Association' or 'CSAH'.

ARTICLE TWO

PRINCIPAL ADDRESS

The initial principal address of the Association shall be P.O. Box 33, Honolulu, HI 96810. The principal address of the Association shall be at such other place in the State of Hawaii, as the Board of Directors shall from time to time determine.

ARTICLE THREE

PURPOSES

The Association has been established as a nonprofit organization for the following purposes:

1. Encourage and promote the sport of soccer.
2. Foster fellowship among the Association members.
3. Encourage good sportsmanship and fair playing among the participants therein.

ARTICLE FOUR

POWERS

In furtherance of the purposes described in Article Three, but not in limitation of such objects, the Association shall have powers permitted to nonprofit organizations under the laws of the State of Hawaii.

ARTICLE FIVE

GOVERNMENT

- A. Board of Directors. The government of the Association shall be vested in a Board of Directors consisting of not fewer than three Officers and no more than eight Managers. The number of Directors shall be fixed by the Board.
- B. Officers. The Officers of the Association shall be a president, vice-president, and secretary. The role of treasurer will be outsourced and funded by the league. The roles of registrar shall herein be incorporated into the duties of the remaining Officers. The duties of each Officer shall be recorded and updated within the 'Coed Soccer Association of Hawaii Rules and Regulations'.
- C. Initial Directors and Officers. The initial Board of Directors shall consist of five persons. The persons listed in Attachment A shall be the initial Directors and Officers of the Association and shall hold their offices for the first year or until their successors are duly elected as established in this Constitution.

Managers. The Board of Directors shall herein consist of all Officers and Managers. The persons listed in Attachment B shall be the newly appointed BOA and shall hold their positions until their successors are selected as established in this Constitution.

ARTICLE SIX

MEMBERSHIP

Active membership in the Association shall be limited to eight teams. Each team must be composed of at least eleven but not more than twenty-five persons and must satisfy the qualifications established in this Constitution and the Rules and Regulations.

ARTICLE SEVEN

AMENDMENTS

This Constitution may be amended by a majority vote of the members at the annual meeting a special meeting called for that purpose in accordance with the By Laws.

ARTICLE EIGHT

BY LAWS

By Laws shall be adopted by the Board as necessary. The By Laws may be amended or repealed, in whole or in part, by a majority vote of the members at the annual meeting or a special meeting called for that purpose in accordance with the By Laws.

ARTICLE NINE

SEASONAL YEAR

The seasonal year shall be from the first of September through the thirty-first of August.

ARTICLE TEN

DISSOLUTION

In the event of dissolution of the Association, its property shall be transferred to the Hawaii Soccer Association (HSA) account.

This organization was formed by the adoption of this Constitution on April 8, 2009.
